PAYMENT & DEPOSIT: We accept Cash or Cheque. There is a non refundable deposit of £30.00 required to secure your booking, this will be deducted from your final balance. CANCELLATIONS: Cancellations should be made no later than 60 days prior to your function. Cancellations made within 60 days will incur a cancellation fee of 60% of the total cost.
